All Saints' Westboro Minutes of Vestry Meeting—February 28th, 2021

- 1. The Ven. Chris Dunn declared the Annual Vestry Meeting in session at 11:20 am with his opening prayer. Archdeacon Dunn added prayers for the following Recently Departed Members of Vestry: Rae Armstrong, Kathryn Bailey, Mary Bradley, Maurice Brush, Martha Leslie Elizabeth Clark, Lillian Evelyn Couvrette, Carol Donnelly, Bette Haining, Herbert "Bert" Eric Jones, Margaret Lee Klassen-Church, Miriam Kumagai, Eric Arie Lugtigheid, Moreen Ursula Miller, Esme Puttick, William "Bill" Rowberry, Olwyn Penrick Schoorl, Aldert Jan "Allan" Schoorl, Timothy "Tim" Aldert Jan Schoorl, Philip Seabrook, Frank William Taylor. "Rest eternal grant to them, O Lord, and let light perpetual shine upon them."
- 2. Vestry Secretary: Michael Norman moved; Catrina Tapley seconded the appointment of Katy Burnett as Vestry Secretary. Carried
- 3. The Vestry Declaration was read, and the declaration was agreed to by 74 people present over Zoom. There were five individuals who returned proxy votes for the meeting. We also welcomed two guests to the meeting over Zoom: Lori Crawford (Westboro Region Food Bank) and Natalie Spooner (Ottawa Food Bank).
- 4. The minutes of the All Saints' Annual Vestry Meeting of February 23rd, 2020 are found on pages 4 to 9 of the All Saints' Westboro Annual Reports document. There was no discussion on the Minutes. Peter Nicoll moved; Eric Bays seconded "the approval of the Minutes of the All Saints' Westboro February 23rd, 2020 Vestry Meeting." Carried.
- 5. The minutes of the All Saints' Special Vestry Meeting of November 19th, 2020, are found on pages 9 to 11 of the All Saints' Westboro Annual Reports document. There was no discussion on the Minutes. Debbie Holzman moved, Doug Fisher seconded "the approval of the Minutes of the All Saints' Westboro November 19th, 2020, Vestry Meeting." Carried
- 6. The All Saints' Westboro Incumbent's Report is found on pages 11 to 14 of the All Saints' Annual Reports Document. The Incumbent noted that a representative from the Ottawa Food Bank, Natalie Spooner, was in attendance at the meeting and invited her to say a few words. Natalie expressed thanks for the good work of the Westboro Region Food Bank. The Incumbent expressed the appreciation of the Parish and the Westboro Region Food Bank to the Ottawa Food Bank for the strong support it is receiving especially during the Pandemic. He further noted his thanks to Lori Crawford for all her hard work in keeping things together during the Pandemic. The Incumbent also noted that Joanne Rowlinson is now the Parish

Representative for Primate's World Relief and Development Fund and that the Parish donated \$5,078.40 to the PWRDF last year in addition to the sale of Christmas Cards. Thanks were expressed to: Julie Newlands for her two years as a warden as she has stepped down to take on the Children and Youth ministry, vacated by the retirement of Barbara Robertson; Patricia Bays, stepping down from being a multi-year delegate to Synod; Barbara Robertson, now retired from many years developing and extending the Children and Youth ministry. The Incumbent noted that Barbara plans to remain active in building on the hospitality work in the Parish. Thanks were given too, to Helen Norman, Parish Administrator, for her work over the past year in very challenging times both personally and professionally.

- 7. The All Saints' Westboro Associate Incumbent's Report is found on pages 15 to 16 of the All Saints' Annual Reports document. The Associate Incumbent echoed the Incumbent's comments in looking back over the past year and recognized all the parish's accomplishments in that time. Simone expressed her gratitude for serving in the parish. When she was on maternity leave last year, she had no idea what was coming up, but everyone's flexibility and graciousness to one another helped tremendously. Simone expressed her thanks to all. She also mentioned her appreciation for the ministry of Jarrett Carty who manages being a full-time professor, a Chaplain to two community ministries, and helping to raise a wonderful family.
- 8. The All Saints' Westboro Financial Reports for 2020 are found on pages 20 to 28 of the All Saints' Annual Reports document.

Barbara Fisher expressed our thanks to Peter Nicoll and Kim Chenger for their work in performing the annual review of our financial statements; their statement can be found on page 20. She also thanked Susan Garnham, our bookkeeper, who provides great support and does a tremendous job of keeping our accounts in order.

Barbara then summarized the reports, starting with the General Accounts found on page 23 of the Annual Report. The General Accounts deal with the day-to-day operations of the parish. She highlighted the various categories of income and noted that all areas decreased during 2020 due to the pandemic and the lockdown for nine and a half months of 2020. The General offerings decreased by \$19,000.

All offerings categories decreased in 2020 compared to 2019.

Parish Organizations such as the New-to-You Shop contributed \$3,840 prior to lockdown; Movies with Meaning contributed \$350 to the parish; but the Quilters were not able to continue with their quilting projects. Note 4 on page 26 provides additional information. The Westboro Village Fair (renamed the Very Virtual Village Fair) was a new venture for All Saints' and was highly successful; thanks to the many people that worked hard to achieve that success the income was \$6,232. Barbara noted that Rentals were also down due to COVID and the lockdown.

On the expenditure side, all areas were down except for the Repairs and Maintenance costs, which were up slightly. Activities costs were down considerably in most areas due to COVID. Our Building & Property Expenses, or Repairs & Maintenance increased slightly over 2019. Note 8 on page 27 of the Reports provides a breakdown of this account. Miscellaneous expenses are mainly due to Professional Sound & Light. Snow removal increased mainly due to timing of invoices.

It is important to note that, for the months of April and May 2020, the Diocese forgave the two months of remittance payments that were expected; this is reflected in the cost of priestly services, lay staff salaries, insurance, and Diocesan Fair Share. The Diocese covered the cost of salaries and insurance during that two-month period.

In the category, Contribution to Joint Building Fund, All Saints' and First United each contribute \$15,000 a year. In 2020, costs to the Joint Building Fund were less than planned. It was decided that the balance from First United would be added to the yearly amount of \$15,000 for 2021. This will give the Committee \$35,773 to work with during 2021. Note 8 on page 27 provides a breakdown of the income and expenses for this account.

Barbara then discussed our Trust Accounts, found on pages 24 and 25. Trust Accounts are divided into three sections: Special Outreach Projects, Other Outreach, and Miscellaneous Trust Funds. The 2020 General Outreach fund was divided evenly to support Ottawa Inner City Ministries, Victoria's Quilts, and Odawa Native Friendship Centre.

The Balance Sheet is a statement of what assets we have (including the Consolidated Trust Funds) and what we owe. A list of what is held in the Consolidated Trust Funds is found on page 28. In 2020, we started with an

accumulated deficit of \$30,728. At year-end we have a surplus of \$9,441—a huge change. (Note chart on page 22)

The Incumbent advised that First United gave a catch-up payment of \$5,773 in 2021 for expenses incurred in the Building Improvement Fund in 2019. Helen Norman pointed out a typo with respect to the spelling of "Schoorl" Family Fund listed on page 25 under Trust Accounts. The Incumbent also offered his thanks to Susan Garnham "for keeping it straight" with respect to bookkeeping in the parish and to Barbara Fisher for all her guidance and support.

Moved by Barbara Fisher; seconded by Jason MacDonald, "that the All Saints' Westboro 2020 Annual Financial Statement be accepted as presented." Carried

9. The Budget for 2021 is found on page 29 of the All Saints' Westboro Annual Reports document. Barbara Fisher introduced the proposed 2021 budget; a working document that represents our best guestimate based on previous experience.

We are proposing a modest increase in offerings for 2021. This is based on information received from the fall stewardship campaign. We have budgeted \$17,000 for Ministry that will come from the Ministry Fund and the St. Matthias Legacy accounts. This will assist with the ongoing adult and children's Christian education programs. Due to current COVID restrictions we are being conservative in budgeting for income from Organizations, the Bazaar, and Rentals of our facilities; in these categories the budget numbers are based on restrictions being lifted by the fourth quarter of 2021. The apartment is budgeted for a full year's rent. Income from investments is based on income from the Consolidated Trust Funds, and once again, we should see a modest increase. Payments from First United are based on historical information, however, the amount received is directly related to the total overhead expenses that First United shares with All Saints'; First United pays for 50% of these expenses.

On the expenditure side the cost of priestly services includes two fulltime priests. We propose maintaining our donation to the Youth Internship Program; we did not participate in 2020. Most of the other operating expenses are within expected increases. The increase in the Diocesan Fair Share portion is based on the average of the previous three years assessable income and is an amount assigned by the Diocese. Based on current circumstances we are projecting a deficit of \$14,570 for 2021.

The Incumbent noted that in the past week, the Diocese had announced that, in a move similar to the 2020 relief package, for the month of March 2021, there would not be a requirement for parishes to remit ECOPS, Lay Salary costs, Insurance, and Diocesan Fair Share. This represents a saving of about \$40,000 for All Saints' Westboro and means that the projected deficit of \$14,570 will be covered.

Discussion followed:

Why is there an increase in the budget for lay staff? Barb Fisher said that with the two months of remittance relief in 2020 our Lay Salary costs were down in 2020, and we have budgeted the full amount for 2021. The Incumbent advised that this relates to the current year too because of the newly announced relief package from the Diocese.

What is the St. Matthias legacy?

Barb Fisher advised that this legacy had been carried over from the amalgamation. The Incumbent advised that \$100,000 had been put in trust after the sale of the Church building. It has been our practice to move about \$8,000/year, if needed, into the Operating budget. The amount was not needed in 2020, so we have budgeted two-years worth for 2021; with the Diocesan relief package for 2021, it may not be needed.

Why is the amount listed under Sundry Income increasing from \$4,677 to \$20,129? The Incumbent noted that certain income amounts do not fit in the normal categories. At the time of amalgamation in 2016, money was withdrawn from the Consolidated Trust Fund to balance the St. Matthias books. We will move the amount in to the Operating Fund, approximately \$20,000, in order to clear it from our books. This is different from the St. Matthias Legacy. If it is not needed it will be carried over to future years.

The Incumbent gave thanks to Barbara Fisher, Corporation, and Parish Council for their input to the budget.

Barbara Fisher moved; Helen Norman seconded, "that the 2021 Budget be accepted." Carried

10. The reports from All Saints' Westboro committees are found in the All Saints' Annual Report document on pages 16 to 18, and on pages 30 to 52. There was no discussion of the committee reports.

Loris Jordan moved; Steve Sibbald seconded, "that the All Saints' Westboro committee reports for 2020 be accepted as published." Carried

11. The Nominations Committee Report for 2021 is found on page 19 of the All Saints' Westboro Annual Reports document. The Incumbent thanked Debbie Holzman, Simone Hurkmans, and Doug Fisher for their assistance on the Nominating Committee. The Incumbent called for changes or further nominations. There were none. The Incumbent thanked Debbie Holzman for staying on another year as Senior Warden, due to Julie Newlands' move from Warden to the ministry of Children and Youth.

Discussion followed:

In the past, there has been a youth member of council. Will this practice continue? The Incumbent reported that this has not worked well recently, but it is something to build on. Problems have arisen with scheduling and school timetables, but we do have the opportunity to add such a position if there is interest. It was pointed out that there was a group of young people dedicated to the Christian Church, being supported by others in prayer. The Incumbent reported that this ministry took place recently over a one-year period, but due to Covid it has been suspended. Right now may not be the time because there are lots of invitations to youth going out. Kids are not at the point of wanting more virtual activity but may be interested in face-to-face activity in the future.

With respect to First United and Parish Council, was there ever a time when each church had a representative on the other's council?

The Incumbent reported that, under the Memorandum of Understanding between All Saints' Westboro and First United, we created a Joint Partnership Management Committee which includes parish clergy, the chair of each Church's council, the treasurers, and an additional representative. Meetings are usually held quarterly, although not always. There is also a Joint Property Committee with equal representation between the two Churches.

Toni Larson moved, Patricia Bays seconded, "that the report of the Nominations Committee be accepted as published." Carried

12. Auditor/Review of the Books for 2020:

Barbara Fisher moved, Lamar Mason seconded, "that Corporation be authorized to appoint an auditor or appropriate persons to Review the Books for 2021." Carried

13. The Signing Authorities for the All Saints' Westboro Anglican Church Bank Accounts:

Michael Norman moved, Susan Stewart seconded, "that the Venerable Christopher Dunn, the Reverend Simone Hurkmans, Barbara Fisher, Debbie

Holzman, Amy Castle, and Jason MacDonald be signing authorities on bank Accounts for All Saints' Anglican Church, Westboro, held in the Toronto Dominion Trust. Carried

Discussion on the motion followed:

A question was asked about the difference between dioceses as it relates to the practice of having clergy as a signing officer?

The Incumbent pointed out that it is the practice at All Saints' Westboro and in the Diocese of Ottawa because the Incumbent is a member of Corporation and has a fiduciary responsibility. It was noted that the practice is different in other dioceses.

A request was made for more detail about signing authorities.

The Incumbent reported that two signatures are required for every cheque and the person signing a cheque cannot sign his/her own cheque. In addition, cheques are prepared by the bookkeeper, Susan Garnham, who does not have signing authority.

A request was made for more information about the concern expressed with respect to the clergy signing cheques.

It was pointed out that some clergy in other dioceses do not want to be holding signing authority so there would be no possibility for concern of misappropriation of funds; some dioceses see it as a best practice intended to protect the clergy. The Incumbent indicated that he is part of Corporation. The important thing is that the clergy is not the sole signing authority and that two people need to sign each cheque.

After these questions, the motion was put, and was **Carried**.

14. Lay administrators for 2021 are:

Stephanie Blain, Alex Bokij, Larry Broome, Sharon Chop, Barb Fisher, Susan Garnham, Janice Gilmartin, Ann Haché, Gaetan Haché, Elizabeth Harris, Janet Holgate, Laurie Jamieson, Chris Kirch, Toni Larsen, Linda Lord, Carol Ann Lugtigheid, Alex Manodon, John Merritt, Michael Norman, Peter Robertson, Stephen Rouble, Steve Sibbald, Marcie Taylor, Craig Thomas, Murray Wilker, and others named by the Incumbent as needed.

The Incumbent thanked Ann Haché for her work as the coordinator of eucharistic ministers. Ann Haché moved; Amy Castle seconded, "that the list of people be appointed Lay Administrators for 2021." Carried

15. General Business:

- a. Installation of Video Screens in the Church for Zoom broadcast and eventually for bulletin projection: The Incumbent noted that this project has been completed. One benefit will be the savings for printing of the bulletin.
- b. Courtyard Garden: The Incumbent indicated that Julie Cross will be reducing her hours in the church garden in the coming year and is looking for assistance with the work. Parishioners are asked to volunteer if they are able. Julie Newlands is canvassing youth. In addition, the Incumbent noted that with the maturation of trees in the Courtyard there is a developing need for a change in the garden's ground cover.
- 16. No further questions of general business were raised.
- 17. Adjournment took place at 12: 30 pm. Murray Wilker moved "adjournment of the 2021 Vestry Meeting." Carried

All Saints' Westboro Incumbent's Report

This is my 14th report to the Vestry of All Saints' Westboro. In last year's report I referred to 2020 as "strange" and "unprecedented". That was certainly the case and our challenges have not changed all that much since. Perhaps we have settled into a way of

dealing with the moves through various levels of protocols. Through all of this the Parish has continued to provide faithful service and worship and the people who share in that ministry in this wonderful place continue to do so faithfully.

Here are some of the highlights over the past year:

- We entered 2021 in "Red Protocols" which meant that from January 2nd to July 4th we offered the Service of the Word on Sunday mornings at 9:30 over Zoom and posting a recorded version of the service on Facebook each week.
- We held weekly Zoom Coffee Conversations on many of the Sundays during the year.
- All of this year's Corporation Meetings, Parish Council Meetings, Staff Meetings and even our Annual Vestry Meeting on February 28th were held on Zoom.
- Our Pancake Supper on February 16th, Ash Wednesday Service, and all our Holy Week and Easter services were held on Zoom and recorded for later viewing.
- Simone and Julie organized mid-Lent and Holy Saturday Dinners on Zoom that included activities for the families and individuals attending.
- We held our first Easter Morning Sunrise Service using Zoom technology and despite the 6:15 a.m. start had a wonderful attendance.
- This year all our Bible on Tap gatherings (led by Simone or Chris) were held on Zoom and everyone was responsible for their own refreshments.
- On June 16th we held a virtual Town Hall to begin discussions as part of the Diocese Shape of Parish Ministry Consultation. We will hear and see more on this in 2022.
- On July 7th the Diocese permitted us to return to limited in-person worship and we held our first Wednesday service in a number of months.
- On July 11th we returned to Sunday Morning in-person worship at 9:30 but continued to provide a virtual option on Zoom, and we continued to post recordings of the worship for some to watch at later times. Having returned to the Celebration of the Eucharist we provided "Drive-by Communion" for those who were with us on Zoom.
- On July 31st the Parish said good-bye to John McGovern during the Funeral held by First United. John helped out for so many years with our building cleaning and in a variety of volunteer roles.
- While I was on vacation in August and September we were pleased to have the Rt. Rev. John Chapman (retired) as the Celebrant at our Wednesday and Sunday worship services.
- On October 3rd we were able to hold both our annual Blessing of the Animals Service and our first in-person Jazz Vespers service in over a year and a half.

- On October 31st we held a wonderful celebration of Baptisms with 5 newly baptized.
- On November 2nd we held a virtual gathering so that the Incumbent could consult about the use of Vaccination Passports/Certificates for attendance at in-person Worship services.
- On November 7th, the Feast of All Saints Day, we returned to holding 8:00 a.m. services.
- From November 13th to 16th we held the Very Virtual Village Fair thanks to the technical support of Debbie Holzman. Shoppers picked up their purchases on November 20th.
- On the First Sunday of Advent, November 28th, we held a very successful collection of items for the "Giving Thursday" program to support our Diocesan Day Programs. A vehicle full of bags and boxes were delivered to the Well on Tuesday, November 30th.
- Our New-to-You shop with its new plastic shields reopened on Wednesdays only in December but soon closed again because of Omicron.
- On December 20th the Diocese returned us to Red Protocols and we had to suspend in- person Worship before Christmas. The Christmas Eve and Christmas Day Services were once again on Zoom.
- Throughout the year I have posted many Puppet Stories, Julie has posted many Church School and Summer Sunday School Videos, and Jarrett posted weekly Lenten Evening Prayer service on the Parish Facebook page.



The biggest change and challenge this year was the loss of the Rev. Simone Hurkmans who moved on to the Parish of St. Alban the Martyr, Ottawa, as their new Incumbent. Simone was a big part of the team at All Saints' Westboro, and we appreciated all of her new and innovative ideas. Whether it was the two Trivia Nights, the giant Prayer Heart in the Courtyard, the Stones of Lament for Residential Schools, or just her

wonderful and engaging preaching, she has been truly missed. The Parish said goodbye on June 27th with a wonderful book of memories and a social distanced Car parade on Madison Avenue.

We have posted recordings of nearly all of our Worship service on Facebook and I want to express my thanks to Mark Holmes for his faithful service in leading us through all the technical ups and downs of Virtual worship. He has trained Nick Wise to take over and Nick is now building the team further.



Throughout all of this, the Westboro Region Food Bank continued to offer its essential service to the community. My thanks to Lori Crawford, who finished her time as our Food Bank Coordinator at the end June. and to Peter Newlands who joined us as Co-ordinator on July 1st. We continue to comply with all the guidelines. Diocesan Ottawa Health Department

guidelines, the Provincial guidelines, and the information sent out by the Ottawa Food Bank. We also want to thank the Ottawa Food Bank for their wonderful support of our program which is one of the 122 agencies that they work with in this great city. Paul Dumais' in addition to all his cleaning duties continues to support the Westboro Region Food Bank at the door, screening those who enter, and receiving items as they arrive.

In addition to the support that I received from Bishop John while I was away, we have also had the Rt. Rev. Michele Pollesel, the Rev. Canon John Wilker-Blakley, the Rev. (Deacon) Jarrett Carty, and Dr. Patricia Bays assist with the preaching this year. Throughout the year we have had the tinkling of the ivories and music leadership from Edith Troup. Helen has done a great job, largely working from home, to prepare bulletins and keep the administration of the Parish going. Julie has worked through all of this with a smile on her face and trying to come up with craft bag ideas keeping the families connected to the Parish. Paul and David have continued to clean and remove snow in what at times has been a very empty building.

My thanks to each of you for your continued support, encouragement, and love for this ministry as followers of Jesus the Christ.

As the executive management committee of the parish, the Corporation meets regularly to make decisions on financial and other matters pertaining to the parish.

Parish Council provides leadership on spiritual, stewardship, and other important business. Our Parish Council members for 2021 included Katy Burnett, Doug Fisher, Chris Kirch, Ken McMillan, Barbara Robertson, Joanne Rowlinson, Scott Sorenson, Susan Stewart, Steve Sibbald (our lay delegate to Synod), plus Parish Corporation members. All meetings were held on Zoom. We appreciate the dedication and contributions of all members of Parish Council.

We endeavoured to include all those who wished to attend a service by always offering live webcasts via Zoom—along with in-person worship when permitted. All Sunday services are also posted on Facebook. We owe much gratitude to our AV tech, Mark Holmes, who managed the audio-visual transmission of Sunday services. We also welcomed Nick Wise who more recently joined the AV team.

Thank you as well to those who assisted with in-person services including Edith Troup who provided beautiful musical interludes during services. These were especially appreciated when singing hymns was prohibited during in-person worship.

Julie Newlands, our Children and Youth coordinator found creative ways to keep our young parishioners engaged through virtual Church School. Julie, along with her grandchildren and others, provided virtual teachings and projects and led in-person Church School when possible.

Property issues continued to be managed by Doug Fisher, Lamar Mason, and the members of the Joint Property Committee. Due to the pandemic, some projects have been put on hold while others have been addressed in a timely and efficient manner. We are grateful to them for continuing to monitor issues during another year of the pandemic.



Our support for the Westboro Region Food Bank continued throughout the year, overcoming pandemic-related challenges. The number of clients increased, the number of volunteers decreased, and the model of operation changed as the pandemic continued. We thanked Lori Crawford for her hard work as the Food Bank Coordinator and welcomed our new Coordinator Peter Newlands in July. The Food Bank space renovation project has been put on hold for now due to the pandemic.

Once again, this year, we ran our November Village Fair virtually. We had planned to add an outdoor sale in October; however, it was cancelled due to inclement weather. Our thanks to the organizing committee of Father Chris, Sharon Chop, Diane Bays, Julie Newlands, Barbara Fisher, Helen Norman, and Debbie Holzman and to all of the volunteers who helped before, during, and after the sale. Thank you to our donors and shoppers who supported this project.

Many other aspects of parish life were put on hold due to the pandemic, including Movies with Meaning. Other events such as the Reading Circle, some Adult Education programs, Jazz Vespers, and Bible on Tap were offered virtually. The New-to-You Shop was able to open for a few Wednesdays in the fall, until pandemic restrictions forced it to close again. Thank you to all those who helped programs to continue.

The 141st session of the Diocesan Synod took place virtually on October 30th, 2021, beginning with the Synod Eucharist the preceding Thursday. Synod 2021 served as a kickoff for the 125th Anniversary of the founding of the Diocese of Ottawa. All proceedings were live streamed. Clergy, Corporation members, and lay delegates attended virtually. The session included the Bishop's Charge to Synod; keynote speaker, Rev. Canon Dr. John Gibaut; a focus on the strategic priorities, laid out in Synod 2020; the unveiling of the new Diocesan logo and branding; the finance report; and elections.

As we move forward into 2022, Corporation continues to look towards the Anglican Diocese of Ottawa and our local and provincial governments for direction regarding the pandemic. We look forward to the time when we can all gather once again in-person at All Saints' Westboro.

The general fund and the trust funds are presented on the balance sheet. Trust funds comprise both externally and internally restricted funds. Detailed income and expenses of the general fund are presented in the income statement. Total receipts and total disbursements are presented for trust funds on page 6.

Assets and liabilities are measured at cost.

Revenue is recognized when received, except for revenue from First United, which is recognized when performance is satisfied. Expenses are recognized when paid, except for employee-related expenses and outreach contributions, which are recognized when the Church has an obligation to pay. The Diocesan Fair Share expense is recognized when paid.

Prepaid expenses are recognized when amounts are paid but the good or service has not yet been received. Fixed assets are expensed when purchased.

All amounts are in Canadian dollars.

Adult Education

Although the pandemic has prevented in-person study groups, we have in fact had a rich banquet of online education opportunities this past year. Thanks to the initiative of diocesan clergy and others, and to the generous invitation of Linda Privitera and St. John's Cathedral in Jacksonville FL, many All Saints' Westboro parishioners have been able to engage in study and reflection throughout the year.

The Diocesan Collaborative Book Study was a multi-parish initiative with learners and facilitators from all across the diocese. In February and March, we explored Richard Rohr's *The Universal Christ* and, in September and October, we read together *An Altar in the World* by Barbara Brown Taylor. These were great opportunities to meet and learn with others from all around the diocese, and a good number of All Saints' people took part.

In April, Linda Privitera and John Wilker-Blakley concluded the Theophany presentations, begun in 2020. In June and July, with the cathedral congregation in Florida, Linda Privitera and Joe O'Shields helped us explore "Poetry, Portraits and Personalities in Pentecost," and in Advent, brought to us "Poetry and Personalities Again: The Gospel Writers Prepare for Christmas."

In May, we had an invitation to join the congregations of St. John the Evangelist, Ottawa, and Temple Israel in a joint study led by the Rev. Gary van der Meer and Rabbi Daniel Mikelberg. This was a unique opportunity to look at passages of Scripture from the perspectives of Judaism and Christianity.

In each Bread for the Saints, I have listed some Resources for Adult Learning—upcoming events, and websites with possibilities for further exploring the faith. Bible on Tap continues each month, led by the clergy. Plans are afoot for other education opportunities and we look forward to another great year.

We particularly want to thank Debbie Holzman, who created the online store; Julie Newlands, who organized all the orders; and Barb Fisher, who looked after the finances.

She put together a great program that included Prayers from diverse sources: A Wee Worship Book, the Book of Common Prayer, the Corrymeela Community, and the Mission St Clare website. The program ran Tuesdays to Fridays throughout Lent. Since it was so popular, Rev. Simone continued to run the program until she left the Parish in June 2021.



Julie Newlands and I were so fond Morning Prayer that we agreed to take over the running of it for the rest of the summer of 2021. As we didn't think we could sustain the program (along with our other duties as Child and Youth Coordinator and Parish Administrator)

four days a week, we changed the days to Tuesdays and Thursdays, alternating between the more traditional services and more modern ones as well as alternating the role of leading the group. In September 2021, with COVID numbers going down, and the church opening up a bit, we decided to finally end Morning Prayer on Zoom, and focus more on in-person worship and activities. And then

In December 2021, right before Christmas, with the omicron variant running rampant and COVID numbers once again going up, the Diocese decided to put us back into the Red zone; this meant that we were back to online worship. So, in January 2022, Julie and I decided to bring back Morning Prayer to help us all through the cold, lonely months of a Canadian winter on Zoom. This time, we are focusing on the prayers from A Wee Worship Book, with modern Bible passages from The Message, and we are holding the sessions on Mondays and Fridays—to start and end our weeks on a high note.

We have a loyal and diverse group of mostly women, although a few intrepid men have joined and have been very welcome (for part of the time, we even had a cute little baby, who livened up our sessions until her mom when back to work and she graduated to daycare)—mostly from Ottawa, but we have had people join from Montreal, Kingston (ON), and Jamaica. Morning Prayer is a lovely way to start the day, and in addition to praying and listening to readings, we always find time to check in with one another and to support anyone who is having a rough time. During these strange times, it is important to keep in touch in whatever way works. Most likely, this session of Morning Prayer will end when Lent 2022 begins, but with circumstances changing every day, you never know . . . we may bring it back when the need arises again.

Joint Property Committee

The members of the Joint Property Committee in 2021 were Doug Fisher, Peter Newlands, and Lamar Mason from All Saints' Westboro and Howard Clark, Don Brodie, and Roger Barliszen from First United. I would like to thank the members for their ongoing efforts to ensure completion of both large and small projects throughout 2021. Much of the work of the Joint Property Committee is invisible to the congregations at large, but it is essential. We are fortunate to have such dedicated members with the expertise we require to research projects, carry them out, oversee them, and obtain the information needed to make sound decisions.

A special shout out to Don, Howard, and Peter who regularly leap in to do minor repairs themselves, so we don't have to call in a contractor. The Joint Property Committee is always happy to call on the expertise of members of either congregation. If you would be willing to lend a hand with small jobs, we would be happy to hear from you.

Unfortunately for us, Peter Newlands had to step down from Joint Property Committee to take on the important role of the Food Bank Coordinator. We wish him well. Roger

Berliszen has also stepped down and we thank him for his efforts while on Joint Property Committee. We look forward to welcoming Steve Sibbald as the newest member of the committee for All Saints' Westboro.

Many of the efforts this year were focused on gathering documentation for potential future efforts. We had a full survey of the property completed, a geotechnical survey done to determine the depth of the church's foundation for potential drainage work, and an interior assessment done to determine building code requirements.

Some of you may have noticed the new roof over the basement entrance to the boiler room. This became a priority in 2021 after concerns about the snow load on the previous flimsy plywood roof. Our custodian will be much safer now in winter.

Other work included a new electrical feed into the building as it was noted by our contractor that the frayed wires from the hydro pole into the church made necessary repairs to the exterior unsafe. It is amazing how the start of one project results in the need for an unforeseen second or third one. Joint Property Committee must constantly be prepared to pivot when it plans its annual projects.

I would like to thank Julie Cross for her continued work in the Courtyard Gardens. This year, she graciously continued to keep the gardens looking their best despite constant threat of destruction because of a planned, but unfulfilled major outdoor project at the church. Thank you, Julie, for your continued patience and dedication. Julie can always use more volunteers to assist her with this valuable mission, so please consider putting your green thumb to work at church!



The day-to-day cleanliness and physical operation of the building depends on the hard work of our dedicated custodian, Paul Dumais. With COVID, Paul has had to adjust his hours and his duties, and I really must thank him for continuing to keep everything running smoothly in the building. David McGechie serves during winter months and as Paul's back-up during vacations, and I know COVID has presented challenges for David as well. A huge thank you to both of them for ensuring the sidewalks are clear, the rooms clean, and the heat on in anticipation of everyone's return to the building. Their work is vital to our enjoyment of our worship space.

Unfortunately, 2022 is starting much the same way as 2021, and we are not using the building as we would like. But there are still maintenance and improvement projects to be done. Please let the members of the Joint Property Committee know if you have any concerns or suggestions for making our worship space better for everyone.

Music at ASW

Following the lockdown that started on December 26th, 2020, our cantors led the hymns each Sunday, through most of 2021. It was a pleasure to work with those who graciously stepped up to lead the hymns so that those on Zoom could sing along: Patricia Bays, Karen Blackie, Dawn Conway, and Wikke Walop. On February 2nd, 2021, Father Chris and Rev. Simone led a Candlemas Hymn Sing on Zoom.

In September 2021, when the Diocese moved into the Yellow stage, we were permitted to sing together as a congregation. Our Choir resumed practices on September 9th and, the following Sunday, formed as a Choir for the first time since March 2020. On October 10th, Thanksgiving Sunday, we were particularly thankful to have Stephen Rouble join us on violin.



The decision of the Diocese to move to the Red stage, on December 20th, 2020, came down the eve of Advent IV. Karen Blackie enthusiastically stepped in to lead the music for that service as the Choir could not attend. Our Christmas services were on Zoom only. Fortunately, the Hume

family had already agreed to lead the music at the 4:00 pm Christmas Eve Pageant. The energy of the solos and blended voices with guitar was joyful, especially on the groovy rendition of Go Tell it on the Mountain. The 10:00 pm service featured Dawn Conway as cantor, and we ended the service by candlelight. On Sunday, December 26th, John Hunter led the hymns as our cantor.

For me, personally and professionally, 2021 was a rich time of learning and reaching out. Through a series of monthly Webinars, Interviews and Chats hosted by The Hymn Society of the United States and Canada and The Centre for Congregational Song, I connected with church musicians from across North America and around the world. These connections allowed me find out how other churches were coping, and to be encouraged and inspired by uplifting stories and ideas.

I connected weekly on Zoom with a group hosted by Music That Makes Community (the "paperless song" group), called "Morning Grounding." We learned new songs and sang together (on mute). I also had opportunities to lead some of the sessions.

From July 9th to 14th, I attended (via Zoom) the 2021 Conference of The Hymn Society of the United States and Canada. It was not quite as exciting as being there in person, but the evening festivals were amazing, and I learned a lot through the sectionals, lectures, and discussion groups. In July 2022, the 100th Anniversary Conference will be held in Washington, D.C. It is being planned as an in-person event, but, like everything else, COVID will make the final decision.

My dream for 2022 is that we will sing together as a congregation soon. In the meantime, keep on singing whenever and wherever you can—we will need our voices to be well-oiled when the time comes to *lift every voice and sing!*

Partnership Management Committee

The role of the Partnership Management Committee is to oversee the partnership with First United and ensure it is working well. The Partnership Management Committee also provides a forum for resolving any issues that arise. The composition of the committee is equal in numbers and role: the All Saints' Westboro and First United senior clergy; All Saints' Westboro's Senior Warden and the Chair of First United's Executive; the treasurers (ex officio); and two members-at-large make up the committee. The committee meets as required to advance the necessary work identified by the Joint Property Committee and to ensure expenses are shared equitably between our two congregations.

The Partnership Management Committee held a comprehensive meeting on March 16th, 2021, which included a congregational check in on how each congregation has fared through COVID-19 noting that both congregations have adapted well, that they have

maintained pastoral and liturgical contact with congregants, and that givings and finances remained intact.

The Partnership Management Committee also addressed the financial and property processes, and the 2021–2023 Property Committee Plan where they expressed a deepfelt gratitude to the Joint Property Committee for their considerable effort and excellent work. The Partnership Management Committee agreed that the Joint Property Committee would proceed with implementing their proposed plans, juggling timelines as they see fit, and operating within the budget that was presently established. The Committee also agreed to authorize the Joint Property Committee to proceed with getting more information and tendering the drainage project. Both Corporation and Parish Council will begin the process of providing provisional approval, with final approval being sought once the scope and price of the project has greater definition.

The Committee agreed that, since it was 10 years since the Partnership Agreement was last reviewed, that a review would occur with a view to examining present financial arrangements.

It was wonderful to count among that group some faithful parish youth and folks from outside our parish. Without your support, we wouldn't have been able to continue for as long as we did.

We are delighted to say that financial support will continue to be given by the Parish to the Parkdale Food Centre.

New-To-You Shop

Website

We continued to provide a list of email updates from clergy as well as updates on church school, programs, and other initiatives. We provided on-line registration when we needed to limit the number of people attending in-person worship services. We offered our virtual Fall Village Fair for a second year in a row.

Westboro Region Food Bank

The Westboro Region Food Bank has been busy keeping up with the everincreasing use of our service brought on by the pandemic in March of 2020. In the period from July 1st to December 31st, 2021, we have had an average of 50+families visit every Monday and Thursday for a total of 1,126 visits. Lately, the average Monday tally has gone from the upper teens to the low twenties. Likewise, the Thursday tallies have gone from the mid-twenties to mid-thirties. Our busiest day saw 40 families use our service.

Fortunately, we have a good support system that has 30 active volunteers,

who do everything from unloading the supply truck from the Ottawa Food Bank, to stocking the shelves and serving our clients. Sometimes the food bank gets hectic, but our volunteers do a great job of making sure our clients are well supplied with food when they leave. All Saints' custodian, Paul Dumais, keeps the peace amongst our clients at the Madison entrance to the food bank, as do Father Chris and Julie Newlands, on occasion.

A "thank you" to Helen Norman, for her assistance in guiding would-be volunteers through the application process.

We are thankful to many people and organizations for their support. All Saints' Westboro is a wonderful home for the food bank, by providing generous support, both financially and physically, and by continuing to accommodate our changing needs for space.

We are thankful to the many people who have dropped off food and cheques throughout the year. The generosity of everyone in the community has been a boost to our morale. In the fall of last year, the Metropole sponsored a fundraising event, as did the Superstore with the participation of the Ottawa Police. On the first Tuesday evening of every month, the West Village Church youth collect food for us in Westboro and deliver it to the Foodbank. At Christmas, Hilson Public School, Churchill Alternate School, Westboro Beach Community Association, and the Barley Mow all collected food and cash donations for us. We also received money raised from a Metropole Christmas event.

This past year, we prepared 160 Christmas Hampers with gift cards for clients to purchase their holiday groceries from Loblaws or the Superstore.

Finally, we were the recipients of a \$26,000 grant from the Federal Government to increase access to the food bank and to buy fresh produce, more dairy and protein. We appreciate the ongoing support of our operations by the Ottawa Food Bank.
